CLARIFICATIONS

The answers for the clarifications sought from the teams on the Moot Compromis are

as follows:

1. What is the structure and role of MZ Capital?

Answer: No clarification required.

2. Who owns MZ Capital?

Answer: No clarification required.

3. Whether Oceanda is a signatory member of the Geneva Convention and Additional

Protocol II?

Answer: Yes, Oceanada is a signatory to the Genevan Conventions of 1949 and their

Additional Protocols.

4. Is Michael Zouzi in any way related to MZ Capital?

Answer: No clarification required.

5. Was it mandatory that all decisions regarding extraction anywhere near the salt mines were

to be initiated only after obtaining a written parchment from the village elders or the

Relacion heads? As paragraph 5 of the Compromis states that "the Relacion heads with

complete operational authority and independence over the extraction activities of the mill

under its control".

Answer: No clarification required.

6. Can you please clarify whether the participants are not allowed to raise any questions

pertaining to any kind of jurisdiction?

Answer: No clarification required. Please refer to the "Notes" appended to the

Compromis.

7. As per the terms of the "Memorandum of Understanding" mentioned in Para 5 of the

Compromis, did the land holding of the plateau change and shift to the Government?

Answer: No clarification required.

8. Para 5 calls Lithensgard/Corporation a "Government owned mill" and a "Joint venture between Sarrakish and the Government" both at the same time, clarification required as to the ownership and form in which the Lithensgard was incorporated.

Answer: No clarification required.

9. What percentage of shares are held by the Sarrakish and/or the relacions before and after divestment?

Answer: No clarification required.

10. What percentage of shares are held by the Government before and after divestment?

Answer: No clarification required.

11. As per Para 11, divestment was proposed to occur in 3 tranches, details required as to divestment of the remaining 75% of the shares of Lithensgard.

12. As per Eudaimonian Accord, were extraction rights and control also taken away from hands of the Sarrakish?

Answer: No clarification required.

13. Referring to Para 12, the various awards won by World Electronics are won before 2005 or post 2005?

Answer: No clarification required.

14. When did World Electronics start taking lithium or other minerals from middle men at Oceanada?

Answer: No clarification required.

15. Para 24- who are "individuals", "government"?

Answer: "Government" refers to the government of Oceanada, while "individuals" refer to the habitants of Sarrak de Nova.

16. Para 30- who are the remaining 2 individuals who have been charged by the ICC Prosecutor?

Answer: No clarification required.

17. Statement of VW 2- In the second paragraph of his communication, fifth line, the word "Company officials" are to mean company officials of SSB or MZ Capital or ADS or World

Electronics?

Answer: "Company officials" is a reference to the management of Lithensgard.

18. Statement of VW1- Main demand of TVF is of collective reparations, however, the description/ purpose of statement of VW1 explicitly states and suggests, he is here to

"identify" victims for purpose of reparations.

19. Is all mineral land, specifically lithium areas owned by Sarrakish tribals?

20. Statement of PW1- para 1, "lastly, unlike SSB.... shares today":

a. What are these issued share bearers?

b. Where and when have they been issued?

c. Are these instruments being issued in Oceanada?

d. Are they banned in Oceanada?

21. Statement of PW 2- second paragraph, first line, since when has World electronics been dealing and taking minerals from Oceanada?

22. PW 3- first paragraph, last line, after incorporation of Lithensgard also were these extraction rights granted specifically by the Relacions? When did this practice stop?

23. Statement of VW1- Exact details as to occupation of VW 1 required. Is it government service or private sector?
