# DEFINITIONS FOR THE PURPOSE OF SYMBIOSIS LAW SCHOOL, PUNE – INTERNATIONAL CRIMINAL TRIAL ADVOCACY COMPETITION, 2025 (SICTA-2025)

The following terms have the corresponding meanings:

- 1.1 "<u>Administrators</u>" mean Director, Symbiosis Law School, Pune; Student Bar Chairperson and the SLSP Student Bar Association of Symbiosis Law School, Pune and / or any other person(s) appointed to administer the Competition by the Director and /or Student Bar Chairperson and /or the said Association.
- "<u>Competition</u>" means Tenth Symbiosis Law School, Pune– International Criminal Trial Advocacy Competition, 2025.
- 1.3 "<u>Disqualification</u>" means that the team will not be allowed to participate in the competition and therefore, shall not be awarded a Certificate of Participation or any Prize. Further, the participating Law College / School / University may not be allowed to participate in any of the future Mooting and other inter alia events organized by Symbiosis Law School, Pune.
- "Judge" means any person appointed to evaluate a Participants' Memorial or Oral Pleadings.
- 1.5 "<u>Student Bar Chairperson</u>" means the Faculty In-Charge of the SLSP Student Bar Association of Symbiosis Law School, Pune.
- 1.6 "<u>Moot Proposition / Compromis</u>" means the official Compromis including the annexures as well as the evidences and testimonies of the Competition supplemented or corrected by any Compromis Clarifications or Corrections as published by the Administrators.
- 1.7 "<u>Memorial</u>" means the written submission by each participating Law College / School / University submitted pursuant to the Rules of the Court.
- **1.8** "<u>Penalties</u>" mean Point(s) deducted for violation of any Rule by the Participants, pursuant to Rule 12.
- 1.9 "<u>Compromis Clarifications</u>" mean the official clarifications of the ORGANIZING COMMITTEE – SICTA 2025 | SYMBIOSIS LAW SCHOOL, PUNE ~ 3 ~



Competition Compromis and of the Rules, as published by the Administrators.

- 1.10 "<u>Participants</u>" mean student representatives from eligible Law College / School
  / University, recognized by the Administrators, participating in the Competition, pursuant to Rule 3.
- 1.11 "**RULES OF THE COURT / RULES**" means the Official Rules of the Competition and any applicable Supplementary Rules.
- 1.12 "<u>SCOUTING</u>" means that participants must only attend rounds in which their team is pleading. Upon the commencement of the oral pleading rounds, participants will not be allowed to interact with the public before they enter their Court Room and shall be seated in a separate room assigned to them by the Administrators.

# **GENERAL INFORMATION**

- 2.1. Symbiosis Law School, Pune is hosting the *Tenth Symbiosis Law School, Pune International Criminal Trial Advocacy Competition, 2025* on International Criminal Law in accordance with the procedure of the International Criminal Court, The Hague, Netherlands.
- 2.2. The Competition has been conceived with the aim of creating awareness for International Criminal Law Jurisprudence and providing a platform for development of advocacy skills which shall further the interest of justice in the domain of International Criminal Law.
- 2.3. The Tenth Symbiosis Law School, Pune International Criminal Trial Advocacy Competition, 2025 is scheduled to be held at Symbiosis Law School, Pune from <u>April 11 to April 13, 2025</u>. The competition will be conducted in an <u>OFFLINE</u> format.
- 2.4. The purpose of organizing the Tenth Symbiosis Law School, Pune International Criminal Trial Advocacy Competition, 2025 is to:
  - 1. Help participants to understand the nuances of International Criminal Justice System;

- 2. Encourage participants to consider careers in the International Justice System;
- 3. Give a real-time simulation of ICC Trial Proceedings;
- Develop participant's understanding on the different roles and planning techniques, etc. employed by the Office of the ICC Prosecutor, defense and victim(s);
- 5. Develop analytical argumentative skills and production of evidences effectively.

# 3. ELIGIBILITY & VENUE

This competition shall be open to all students actively enrolled in Bachelor (Five-Year Course & Three-Year Course) and Masters Programme of Law. Exchange students may participate on behalf of their host university.

The competition will be conducted in <u>PHYSICAL MODE</u> for all national and international teams in Viman Nagar Campus of Symbiosis Law School, Pune.

# 4. COMMUNICATION MEDIUM OF THE COMPETITION

The competition shall be organized and conducted in the **ENGLISH** language.

# TEAM COMPOSITION

- 5.1. The maximum number of participants per team shall be restricted to 3 wherein only2 of them can be Speakers. Both the speakers must compulsorily examine the witnesses.
  - **5.1.1.** Only the Participant who is a Speaker in all three Preliminary Rounds shall be eligible for the award of the Best Speaker.

- **5.2.** The identity of the team [name of the Law College / School / University] must not be disclosed to the *Judges* as well as to the other *Participating Teams*. Any such disclosure shall lead to disqualification under Rule 12.
- **5.3.** No Team Coach or Assistant or any other person shall be accompanying the Team other than the specific registered participants.

# **REGISTRATION**

- 6.1. It is an **INVITE ONLY** Competition.
- 6.2. The Registration fees is Rs.20,000/- (including GST) per national team and USD 300 for International Team (inclusive of food and accommodation for the dates of the competition) [not more than 3 members].
- 6.3. The Registration Fee shall be non-Refundable.
- **6.4.** No change in the names of the participants shall be permitted after the receipt of the Registration Form, except at the sole discretion of the Administrators.
- 6.5. Only one Team is allowed per Law School / College / University.
- 6.6. There will be a three-tier Registration Procedure.
  - 6.6.1. Invite Only: Only the Law School / Colleges / Universities which have been sent the Invite for the Competition are eligible to register for the Competition. <u>All other Law Schools/Colleges/Universities seeking participation in the competition shall do so by sending a request to the Administrators. Decision upon the same shall be the sole prerogative of the Administrators.</u>
  - 6.6.2. The registration is only on a *first-come-first-serve* basis and is reserved for only 24 Teams, which may be increased to 27 Teams at the sole discretion of the Administrators.

#### 6.6.3. Provisional Registration



6.6.3.1. The Teams should reply to the Invite sent by the Administrators to book a slot for the Competition by February 10, 2025 (Monday).

# 6.6.3.2. <u>The team shall not transfer any amount at the stage of Provisional</u> <u>Registration.</u>

- 6.6.3.3. Symbiosis Law School, Pune holds no responsibility for any transfer of registration fee made thereto without the permission of the Administrators.
- **6.6.3.4.** On confirmation of the Team Slot by the Administrators, the Team should complete the Registration with Symbiosis Law School, Pune by furnishing the administrators with the following information:
  - **A.** Authorization Letter; and
  - **B.** Proof of Payment of Registration Fees.
- 6.7. Registration Fee:
  - **6.7.1.** The mode of payment and corresponding details for the registration fee shall be conveyed to the participants along with the official confirmation of their provisional registration.

### **MEMORIALS**

- **7.1.** Each team must prepare memorials for the Prosecution, the Defense and the Victim(s).
- 7.2. The soft copies of the memorials must be emailed to <u>symbiosismoot@symlaw.ac.in</u> and the subject of the mail should be marked as "Memorial Submission by Team Code \_for Symbiosis Law School, Pune International Criminal Trial Advocacy Competition, 2025" by March 31, 2025 (Monday) before 07:00 p.m. IST (1900 hours).

- 7.3. The soft copy of the memorial for each side shall be a single file (All parts of each memorial must be in a <u>single document</u> i.e., Separate Ancillary Pages and Arguments in Detail are NOT allowed), and should be sent in both PDF (\*.pdf) and MS Word (\*.doc / \*.docx) versions. The memorial for the Prosecution, the Defense and the Victim(s) should be sent in the same first mail.
- 7.4. Soft copy of Memorials submitted after the stipulated time i.e. [March 31, 2025 (Monday) after 07:00 p.m. IST (1900 hours) will attract a penalty of Five (5) marks for each hour of delay and Ten (10) marks for delay of each next day i.e. [from April 01, 2025 (Tuesday) 12:00 a.m. IST (0000 hours)]. The Memorials will only be accepted till 07:00 p.m. IST (1900 hours) on April 01, 2025.
- 7.5. The (9) hard copies of the memorial (3 copies for each side) must be submitted on April 11, 2025. The memorials must be spiral bound and printed on both-sides.
  - 7.6. The 'Arguments in Detail' and the 'Prayer' in each memorial should not exceed more than 7,500 words excluding Footnotes.
  - 7.7. The memorials <u>should not contain the name of the participating Law College /</u> <u>School / University, name of the participants, name of the country of the</u> <u>participating Law College / School / University or any identification</u> in any part thereof. No logo or any mark of identification should be made in the memorials. Noncompliance with this rule will lead to immediate disqualification.
  - 7.8. The memorials must contain the following:
    - 7.8.1. Cover Page;
    - 7.8.2. Table of Contents;
    - 7.8.3. Index of Authorities;
    - 7.8.4. Statement of Facts;
    - 7.8.5. Issues Presented;
    - 7.8.6. Summary of Arguments;

- 7.10. The Cover Page of each memorial must contain the following information:
  - 7.10.1. The Team Code should be mentioned in the upper right-hand corner. For instance, if the Team Code of the Participating Team is SICTA\_150; the Memorial Code on behalf of Prosecution would be "SICTA\_150\_P", for the Defense would be "SICTA\_150\_D" and for the Victim(s) would be "SICTA\_150\_V".
  - 7.10.2. Name of the Competition.
  - 7.10.3. Year of the Competition.
  - 7.10.4. Name of the Case [Name of the Parties].
  - 7.10.5. Party for which the Memorial has been prepared.
  - 7.10.6. Name of the Forum resolving the dispute.
  - 7.10.7. Word count.
  - 7.10.8. Charges against the Accused.
- 7.11. The Memorial SHALL NOT contain any Annexure / Photographs / Sketches / Exhibits / Affidavits etc.
- 7.12. The Memorial shall be formatted according to the following specifications:
  - A. Typed on standard A4 size page.
  - B. Font Type: Times New Roman
  - C. Font Size of the Body Text: 12

- **D.** Font Size for Footnotes: 10
- E. The text of the Memorial and Text of Footnotes should be 1.5 lines spaced.
- **F.** Font Size for the Cover Page may be 14 or 12.
- G. Margin: 1 inch or 2.54 cm margin on each side of the A4 size page.
- H. Quotations of sources of 50 words or more in any part of the memorial should be block quoted, indented.
- I. The participating teams should include the Header and Footer in their memorials to the effect that the Header should mention the full Name of the Competition, and the Footer should mention the page number and the side on whose behalf the memorial is submitted.
- J. The Page Number should be mentioned at the Bottom Left Corner of the Page. The <u>Ancillary Pages</u> should be numbered in *Roman Numeric* and the <u>Arguments in Detail</u> should be numbered in *Alphanumeric*.

# 7.13. The footnotes must follow the *Harvard Bluebook Method of Citation*, 20<sup>th</sup> *Edition*.

- 7.14. The memorials will carry a *maximum of 100 marks each*. The marks scored by the teams in the memorials <u>will be added only to the three preliminary rounds</u>. *The weightage of Memorial Marks shall be 30% of the Total Scores in each Preliminary Round*.
- 7.15. PARAMETERS FOR JUDGING THE MEMORIALS ARE:
  - Logical development of ideas;
  - Novelty in analysis and arguments;
  - Variety & depth of research (new points and unique interpretation of fact/law);

- Understanding pertinent legal issues;
- Clear, concise and unambiguous writing style;
- Integration of facts into legal argument;
- Appropriate inference of the facts from the Evidence;
- 8. Understanding of strengths and weaknesses of the case;
- 9. Discussion of viable alternative arguments;
- 10. Proper use of citations and citation form;
- 11. Effective use of authority to support arguments;
- 12. Ability to distinguish adverse cases &
- 13. Neatness, legibility and formatting.

# 8. ROUNDS

8.1. Advocate Attire / Dress Code:

8.1.1. The dress code during the competition rounds shall be Formal Wear.

### 8.2. Number of Rounds:

- 8.2.1. Three Preliminary Rounds
- 8.2.2. Semi-Final Rounds and
- 8.2.3. Final Round

# 8.3. Orientation Program:

8.3.1. There will be an Orientation Program for all the participants on *April 10<sup>th</sup>*, 2025 (*Thursday*).



- 8.3.2. It will be followed by a draw of lots & exchange of memorials.
- 8.3.3. Thereafter, Sides for Pleadings will be allotted.

#### 8.4. Preliminary Rounds:

- 8.4.1. There will be three preliminary rounds of arguments per team, one on behalf of the Prosecutor, other on behalf of Defense & another on behalf of Victim(s).
- 8.4.2. The teams will be allotted the sides mentioned in Rule 8.4.1. based on the draw of lots and fixture. No team shall appear before each other more than once in the Preliminary Rounds. Each team will face a different Bench in their Second and Third Round of the Oral Pleadings.
- 8.4.3. Preliminary Rounds will be held from *April 11<sup>th</sup>-12<sup>th</sup>*, 2025, and the top nine teams will qualify for the Semi Final Rounds.
- 8.4.4. The top nine teams shall qualify on the basis of rounds won (three wins), wherein each round shall carry 70% weightage of Each Oral Round Marks of the Team and 30% weightage of the Total Marks secured in the Memorials submitted by the Team. In case of a tie, the team with the highest Preliminary Oral Round Marks shall qualify for the Semi- Final Round.

### 8.5. Semi-Final Round:

- 8.5.1. The Semi-Final Round shall be a Knockout Round and will be organized on April 12<sup>th</sup>, 2025 (Saturday).
- **8.5.2.** The Teams winning the Semi Final Round in their respective Trial Chamber shall qualify for the Final Round.
- **8.5.3.** The roles of the top nine qualified teams shall be determined through the selection of side by the teams through draw of lots.

### 8.6. Final Round:

**8.6.1.** The winner from each Trial Chamber of the semifinal round shall qualify for the Final Round.

- **8.6.2.** The roles of the teams shall be determined through the selection of side by the teams through draw of lots.
- 8.6.3. The final round will be conducted on April 13<sup>th</sup>, 2025 (Sunday).

## 8.7. Results:

- 8.7.1. Results of Preliminary Rounds and Semi-Final Rounds will be announced within 120 minutes after the completion of these Rounds.
- 8.7.2. The result of the Final Round and the winners of the various categories will be announced only during the Valedictory and Prize Distribution Ceremony scheduled on April 13<sup>th</sup>, 2025 (Sunday).

  - 6. Examination of PW-1 by Victim(s) Counsel
  - 7. Examination of PW-1 by Defense Counsel

# 9.2 Marking Criteria for Oral Pleadings:

The judges will assess the performance under the following heads:

- Knowledge of the facts;
- Proper and articulate analysis of the issues arising out of the facts;
- Understanding of the international legal principles directly applicable to the issues;
- Ability to explain clearly international legal principles in general adherence to the time allotted;
- Knowledge and use of legal sources: treaties, custom, general principles of international laws
- Ingenuity (ability to argue by analogy from related aspects of international law);
- Logic and reasoning;

- Organization and clarity;
- Persuasiveness and Deference to the court;
- Understanding of Law of Evidence and Procedure related to the ICC;
- Ability to train the witnesses during the witness briefing session in the stipulated time of 30 minutes.

# 10. WITNESSES

### **10.1 General Rules**

**10.1.1** The witnesses are assigned to every participant team (2 witnesses per team based on the side allocation) for the purpose of conducting examinations during the oral rounds and to provide testimony based on their knowledge or experience regarding the case, helping the court establish facts and reach a verdict.

### **10.2 Witness Briefing**

**10.2.1** Based on the side allocated to the teams, their respective allocated witnesses will be allotted. The respective two allocated witnesses will be introduced to the participant teams. It is the team's responsibility to brief the witnesses on their expected conduct in the courtroom and guide them on how to respond to questions posed by opposing counsel or the judges.

**10.2.2** The witness briefing sessions will be held for 30 minutes by the participating teams before the commencement of the oral rounds. Within these 30 minutes, the participant teams must effectively brief the witnesses. No additional time will be given for the same and the responsibility of such effective briefing rests solely on the participant teams.

#### **10.3 Oral Pleadings**

**10.3.1** Each witness will be given a specific time to plead the case along with the adequate cross-questioning time which will be shared via the Procedural Order in due time.

10.3.2 The assigned time for examination of each witness is as follows-ORGANIZING COMMITTEE – SICTA 2025 | SYMBIOSIS LAW SCHOOL, PUNE ~ 15 ~

- a. Examination in Chief by ICC Prosecutor- 8 minutes
- b. Examination by Victim Counsel- 6 minutes
- c. Examination by Defense Counsel- 6 minutes

#### **10.4 Miscellaneous**

**10.4.1** Witnesses for the competition will be selected by the Organizing Committee and are <u>randomly assigned</u> to fixtures and courtrooms prior to the oral rounds before the team is allotted to such courtroom. No complaints regarding the allotment of witnesses shall be entertained by the Organizing Committee.

**10.4.2** Teams will be evaluated based on the effectiveness and clarity of their briefing to the witnesses. The briefing should ensure that witnesses are well-prepared to handle the examination effectively within the courtroom.

**10.4.3** Teams are fully responsible for the behavior, conduct, and performance of their assigned witnesses during the oral rounds. The Organizing Committee will not be held liable for any issues related to witness conduct, performance, or merit in the courtroom.

**10.4.4** No complaints or grievances will be taken up by the organizing committee regarding the intellectual capacity of the witnesses as the responsibility to effectively train the witnesses lie on the team itself.

**10.4.5** To help students understand the role of a witness, witness briefing sessions were conducted prior to the competition. These sessions, however, were purely for academic learning purposes and bear no connection to the facts or issues in the moot compromis. Teams should note that the preparation and performance of witnesses during the moot will rely solely on the team's briefing prior to the rounds. **10.4.6** Witness anonymity must be maintained by both the participating teams and the student witnesses.

**10.4.7** No chits or notes can be taken inside the courtroom by the witnesses passed from the teams or otherwise. While participant teams can show the same while conducting the briefing sessions, the same cannot be carried by the witnesses during the proceedings.

#### 11. ANONYMITY

**11.1.** Participants may introduce themselves to the court by their individual code only.

- **11.2.** The team's college name should not be mentioned at any time.
- **11.3.** Further, all team members, coaches, advisors and observers shall refrain from identifying a team's school/college at any time and in any manner, including, but not limited to, wearing and carrying any identifying items, such as badges, blazers, or pins or carrying identifying material (such as a book with a college logo, or college seal).

# 12. PENALTIES & DISQUALIFICATION

Notwithstanding anything written as a part of the abovementioned rules, the following penalties shall be levied on the participants:

A. Disqualification of the Team on the grounds of:

# i. SCOUTING.

**Breach of the ANONYMITY** as provided under **Rule 11** in any of the following circumstances:

- i. During the Oral Proceedings, either before the Judges or other participants, or
- Through passing of any note or research material during the Oral Proceeding, or
- iii. Through any such identification of team's Law School / College / University at any time and in any manner, including, but not limited to, wearing and carrying any identifying items, such as badges, blazers, or pins or carrying identifying material (such as a book with a college logo, or college seal), or

iv. In any manner through the Memorial Submitted by the Team, as provided under Rule. 7.6.

**B.** Submission of Soft copies of the Memorial in two parts i.e., Separate Ancillary Pages and Arguments in Detail is not allowed. The memorials should be sent in the same first mail. Pursuant to **Rule 7.3**. Non-compliance shall attract a penalty

- C. The "Arguments in Detail" and the "Prayer" in each memorial should not exceed more than 7,500 words excluding Footnotes. Pursuant to Rule 7.5, failure to comply with the Word Limit shall attract a penalty of Two (2) Marks per 100 words.
- D. Non Compliance on mentioning the pages contained in the memorial under Rule 7.7 except Rule 7.7[A] and Rule 7.7[G], shall attract a penalty of Half (0.5) Mark from each side.
- E. Non-compliance of Rule 7.8 providing for color scheme of the Cover page (hard copy) shall attract a penalty of One (1) Mark from each side.
- F. Non-compliance with the rules under 7.9[B], 7.9[C], 7.9[E], 7.9[F], 7.11[A], 7.11[C], 7.11[D], and 7.11[G]shall attract a penalty of Half (0.5) Mark from each side
- G. Non-compliance with the rules under 7.9[D], 7.9[G], 7.11[B], 7.11[E], 7.11[I] and 7.11[J] shall attract a penalty of One (1) Mark from each side.
- **H.** Non-compliance with the rules under **7.12** shall attract a penalty of **Two** (2) **Marks** from each side.
- I. Non-Adherence to any of the Rules of the Competition or any Rules of the Organizing College and misbehavior or unlawful conduct by the participating team from any College / University / Law School will result in disqualification of the team from the Competition.

# 13. DECISION

- **13.2.** Decision of the Administrators shall be **BINDING** in interpretation of any rules of the procedure or for any query except as mentioned under clause 12.1.
